## 2 OBJECTIVES

The staff will also deliver the campers to the corresponding station once the Skate Camp is finished, prior notice, on Saturday, between 14:00 and 20:00 h.

A week before the camp starts we will be contacting each parent / tutor in order to establish the exact date and place of departure. Do not worry if your schedule does not match the above described. We will pick up or embark the participant at your requested schedule, always within the established days.

We will carry out many outdoor activities. Dirt will be part of daily life in the camp. This is why you will not need to bring brand new clothes. Already used clothing is comfortable and perfect to enjoy camp to the fullest.

For those participants staying 2 weeks at the camp, we have a chance to wash dirty clothes if needed.

We recommend not to bring valuable objects such as Mp3, electronic devices, cell phones, etc. in order to avoid damages, etc.

We allow the use of cell phones, but only between 09:00 am and 10:00 am and between 20:30 and 23:00. If a participant ignores this rule, the phone will be confiscated until the end of camp.

# 6 CONDITIONS

Please carefully read the following terms and conditions established by Emilio Arnanz (from this point on the organization) for the Element Skate Camp Spain 2017.

## ▲ REGISTRATIONS

- In order to make a reservation you must fill out the following documents and send them to us via Email or fax (ANNEX 1, 2, 3). The reservation shall be completed upon payment of a guarantee deposit of 150 euros (300 euros in the case of 2 weeks camps) via bank transfer.
- Upon reception of the bank transfer, your reservation shall be confirmed and we shall contact you (parent/guardian). This guarantee deposit shall be deducted from the total amount to be paid for the camp and must be paid at least 15 days prior to the beginning of the skate camp you are registering for (500 / 900 euros).

## ▲ CANCELATIONS

### AMOUNT OF THE RESERVATION

All cancellations must be communicated in writing (via fax or Email) clearly stating the name of the participant whose registration is to be cancelled, as well as the account number (20 euros digits) that should be used for refunding the amount that might correspond.

- Cancellations made beyond 31 days prior to the beginning of the camp shall qualify for a full refund less a 50 euros administrative fee. (100 euros refund)
- In the case of cancellations made between 31 and 15 days prior to the beginning of the camp, the organization withholds 20% of the reservation plus a 50 euros administrative fee (70 euros refund)
- In the case of cancellations made within 15 days of the beginning of the camp, or if the registered participant should not show up at the beginning of the activity, the organization withholds the full amount that has been paid and no refund applies.

### DURING THE CAMP:

Should any of the participants get hurt or have to leave the camp during the first two days, he/she shall be entitled to a 40% discount in another camp in the future.

### CANCELLATION OF THE CAMP:

The organization reserves the right to cancel the activity at its sole discretion 30 days prior to the beginning of the camp if minimum enrolment (20 participants) should not be met for the chosen week.

In such case, 100% of the amount so far paid shall be refunded.

## ▲ LIABILITIES

### LIABILITY OF CLIENT TO THE ORGANIZATION

Participants have some liabilities to the organization and the other members of the camp. All participants must understand and comply with the terms of this contract, the agreement of participation and the code of conduct.

### LIABILITY OF THE ORGANIZATION TO THE CLIENT

Our goal is to offer the best possible camp and we shall struggle to achieve this. The organization assumes any liability related to damage or loss as a result of the negligence of the organization or any of its employees. The organization is not liable for damage or loss caused by another participant. The organization reserves the right to expel any participant who does not comply with our instructions and those whose physical or psychological condition represent an inconvenience for other participants or a danger for themselves or for the other members of the group. In such cases no refund applies.

### DISCLAIMER OF LIABILITY

The organization is not liable for any inherent risks that might result in unfortunate accidents or incidents that should take place in normal circumstances during the camp. The organization is not liable for injuries, death, damages, losses, delays or inconveniences arisen during the camp due to causes beyond its control. No refund applies in cases of acts of God (floods, etc.), national or global instability, or political instability.

### WEATHER CONDITIONS

We all expect weather conditions to be excellent. Unfortunately, sometimes weather conditions might not be as good as we would like. The organization shall not be liable if weather conditions are not satisfactory. In such case, the organization shall provide for indoor facilities where we can use the portable skate modules Element "Drop Spot", in addition to visits to indoor skateparks in the area: Santander, Bilbao, etc...

# PARTICIPATION AGREEMENT

**AS DEALING WITH MINORS, ALL REFERENCE TO "PARTICIPANTS" SHALL INCLUDE THE FATHER/MOTHER/GURDIAN, WHO ACTS IN THIS AGREEMENT IN HIS OWN NAME AS THE LEGAL REPRESENTATIVE OF THE MINOR**

The Participant requests to form part of the "Element Skate Camp Spain" organized by Emilio Aranz Granda (from this point on the organization) in the session and dates indicated in the attached Data Sheet. Parents authorize the participation of his son/daughter and certify that they have reviewed with him/her the information of the program, and have become familiar with the program and the activities in it included. Parents allow their child's participation in all camp activities (except those who have requested that the Participant is excluded due to medical or other reasons, which are specified in the data sheet).

The Father / Mother / Guardian knows and understands that any sponsor/collaborator of the skatecamp and GSM Europe, legal owner of the ELEMENT brand, doesn't participate in the organization and camp management and that its relationship with Emilio Aranz Granda (the organization) and the Skate Camp is merely as a sponsorship or partnership. Therefore any of them are released from all liability for damages and losses of any kind that may result from the development of the activities carried out in the camp.

The Father/Mother/Guardian certifies that he/she has given his/her son/daughter the pertinent instructions so as to make him/her understand the importance of acknowledging and obeying the rules, regulations and safety procedures of the Camp. The Participant has read the Code of Conduct (attached), recognizing its importance and is committed to meet all its requirements.

The organization reserves the right to terminate – without any refund- any participant whose conduct – in the opinion of the coordinators – is in detriment to the harmony and correct development of the camp's activities, to his/her own safety or that of the other participants, or violates the rules of the Code of Conduct. Should this happen, parents will be notified and will be responsible for the participant's transportation, not later than 24 hours after notification, as well as for covering any expenses incurred by the organization because of this suspension.

In our skate camp the safety of the participants is a top priority; this is why an analysis of potential risks to which participants are exposed, stating appropriate ways to minimize them, is carried out. Participants have a civil liability insurance and every reasonable precaution is taken in order to ensure that programs are conducted by qualified staff in a safe and responsible manner. However, there are certain risks due to the type of the camp's activities (skateboarding) as well as to the natural environment. Among them the following (but are not limited to) are included: transportation, sports, challenges, field trips and cultural visits, games, climate change, plants and insects. It is important to admit that these and other risks which have not been mentioned are inherent to the program and must be accepted by the participant and/or his/her parents.

The participation in the camp can be physically and emotionally demanding for some people. The Participant and the Parents/Guardians are required to notify the organization any problem or situation that requires medical supervision, infectious diseases, physical or psychological needs, or special care needed by participants (this information must be recorded in the data sheet). The consequences arising from the absence of such information are the responsibility of the Participant and the Parents/Guardians. The Participant must submit a medical certificate\* 15 days before the start of camp.

\*The contribution of the medical certificate is considered a prerequisite in order to participate in the camp. As a result, the failure to provide the said certificate within the period stated unables the Participant to take part in the camp, without refund of the paid amount.

When a Participant – due to his/her health condition previous to the Camp – requires special treatments, he/she will have to provide the necessary medicines in their original boxes and in sufficient quantities. The organization expenses incurred by such situations will have to be covered by the Parents/Guardians. If discomfort does not repeat, the organization is authorized to deliver first aid medicines (which do not require medical prescription). If an accident or illness were to occur, Parents/Guardians will be immediately contacted or, in case of no response, the emergency phone number provided. In case of an emergency the organization is authorized to allow medical care to be granted, as well as hospitalization and necessary treatments. Also the organization is authorized to distribute information about the Participant to the camp's staff who may require it, and if necessary, disclose medical information to external medical staff.

In compliance with the provisions of Organic Law 15/1999, of Personal Data Protection, you are informed that the provided data will be included in a data processing file ownership of Emilio Aranz Granda. This file is intended to manage and control the services under contract as well as to send commercial communication of the services provided by the owner. All data included in the forms are mandatory and refusal would mean the inability to contract the offered activities.
